Vassar College

Report on Required Student Aid and Institutional Portion of HEERF II Funds The Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) June 2021

Vassar College reports herein that it has drawn down the full amount of Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) funding for student grants and institutional needs.

STUDENT AID PORTION

The amount of funding the institution received for Higher Education Emergency Relief Fund-Student Aid is \$917,811.

The total amount of Student Aid funding distributed as of April 15, 2021 to 569 students is \$917,811.

The total number of students at Vassar College who were Pell-eligible and provided with the opportunity to apply for Student Aid is 1,506.

Vassar College determined which students would receive CRRSAA Student Aid Grants and how much they would receive as follows:

Vassar College's Office of Student Financial Services provided a list based on who had completed a FAFSA for the 2020-2021 academic year and successfully satisfied all requirements that apply to Title IV eligibility. A total of 1,506 students were identified as meeting these criteria and being actively enrolled for the Spring 2021 semester.

In an acknowledgement of diverse student experiences and circumstances, we included an option that allowed students to indicate they did not need to apply for Student Aid Grants and would instead leave it in the pool of funds that would be distributed to those in greater need. Referring to federal guidance, we prioritized those who were most in need, based on their Financial Aid Status, Pell Eligibility, Family Income Level, and individual student reports as to how they have been financially impacted. This included an opportunity to provide a narrative to further expound on the needs. We followed a rubric to review applications and assigned to high, medium or low priority in terms of need and the above criteria.

The application and guidance provided to students by Vassar College concerning the Student Aid Grants is available below.

INSTITUTIONAL PORTION

The amount of funding the institution received for the Institutional Portion is \$1,850,259.

The total amount of Higher Education Emergency Relief Fund-Institutional Portion funding distributed as of April 16, 2021 is \$1,850,259.

Vassar's institutional portion was used to fund the following:

- --\$39,909 for additional Student Aid Grants to cover emergency costs due to coronavirus.
- --\$1,810,350 was applied to Vassar's Institutional Costs associated with coronavirus in various categories as detailed in the form below.
